A summary of the proposed rates is as follows:

Rates shall be increased annually by 3.0% every June 1, starting 2025.		

Big White Water Utility Ltd. has completed a comprehensive capital plan and asset management assessment in order to ensure quality, resiliency and efficiency. Rates were last updated in 2016 when a Replacement Reserve was created; however, have not otherwise been updated since 2003. During this time, many improvements and upgrades have been undertaken, including the construction and commissioning of the Powder Basin reservoir and water treatment plant.

The proposed increases are necessary in order for the utility to continue to provide quality, reliable service to all our customers. The increases ensure that ratepayers fund the rehabilitation and replacement of current works, and development will continue to fund the expansion and extension of the system, both held in a separate trust funds for these purposes.
